The Certified Business Advisors® that staff the SBDC offer integrated services to meet the needs of experienced small business owners, as well as individual entrepreneurs. SBDC Specialty Programs

Manufacturing and Technology Small Business Development Centers (MTSBDC)

Through the MTSBDC, manufacturing and technology specialists provide businesses with one-on-one counseling to assist in the development and commercialization of innovative technologies and advanced manufacturing. Specialists provide manufacturers with fewer than 50 employees with management counseling and educational services in the following areas:

- Lean manufacturing
- Business process improvement
- · New product development and commercialization strategies
- · Strategic and business planning
- Technology marketing
- Licensing strategy
- · Basics of patenting, trademarks and copyrights
- Intellectual property issues and marketing
- · Licensing basics

International Trade Assistance Centers (ITAC)

Through the ITAC, international trade specialists provide export assistance and focus new-to-export businesses and exporters on expanding overseas markets. ITAC promotes business development by offering international market opportunities; increasing small business export transactions and export sales; and supporting the future competitiveness of Ohio companies through their participation in the global market.

Latino Small Business Development Centers

Staffed by bi-lingual personnel, the Latino SBDC provides counseling and training in Spanish to start-up and existing businesses. Marketing and outreach is conducted through various Latino media (TV, newspapers, radio and magazines). The Centers cover core business management practices, access to capital, business plans, strategic planning and risk analysis.

Ohio Rehabilitation Services Commission Collaboration

Ohio Abilities is a program collaboration between the SBDC and the Ohio Rehabilitation Services Commission that helps Ohioans with disabilities explore self-employment and microenterprise opportunities to start, sustain and grow their businesses.



Restored Citizen Program

The SBDC's Restored Citizen Program provides high-quality entrepreneur workshops and training throughout Ohio to restored citizens who are ex-offenders through partnerships with re-entry job readiness programs. This program, along with the SBDC DVD series "Restoring Ex-offenders into Society through Entrepreneurship and Training (RESET)," provides resources, motivation, and information to inmates, ex-offenders and the community at large regarding entrepreneurship opportunities as a means of re-transitioning into mainstream society upon exiting the correctional system.

Youth Entrepreneurship Programs

The SBDC Network of Ohio, in partnership with education, civic, business or faith-based organizations, encourages entrepreneurial thinking and teaches the basic concepts of business ownership to young people throughout Ohio.

For existing businesses, SBDC offer advanced training tracks to help businesses expand or improve their performance.

Integrated Quality Assessment[®] (IQa) (for existing businesses)

This assessment provides a holistic review of a business, focuses on improvements needed for long-term growth, provides leads to potential unexplored areas of business practices, and helps companies begin developing and implementing key operating systems. IQa is based upon the nationally recognized principles and the seven performance excellence criteria used by the Malcolm Baldrige National Quality Program and the Ohio Award for Excellence.


